Dear Ms. Abritis:

This letter is the final response to your May 8 21, 2018, Freedom of Information Act (FOIA) request with the National Institute of Health (NIH). On September 21, 2018, NIH referred your request to the Department of Health and Human Services (HHS) for direct response to you. On September 26, 2018, HHS emailed you an acknowledgment letter for your request. Specifically, you requested the following records: "This is a request under the Freedom of Infromation Act. I request the following records: 1. Any Correspondence between the Office of Policy for Extramural Research Administration (OPERA) and officials at Duke University during the month of March 2018.."

The Office of Research Integrity (ORI) conducted a search and reports there are no records responsive to your request.

While we believe an adequate search of the appropriate files was conducted for the records requested, you have the right to appeal this finding that no responsive records exist within ORI. By filing an appeal, you preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision.

Please mark the correspondence, "Freedom of Information Act Appeal." Your appeal must be transmitted within 90 days from the date of receipt of this letter to:
