Thank you for asking me to provide an opinion relating to the publication of the above paper authored by Ziade NR, Mallak I, Merheb G, et al. in Front Immunol. 2019;10:574 and Prof Fayad current and past involvement in the research leading to the publication of the said paper. I also very much appreciate the provision of focused precis of the most relevant aspect s of the case in hand in addition to providing important copies of reports of other learned colleagues.

PLEASE NOTE THAT I AM PROVIDING MY INDEPENDENT OPINION AND IN NO WAY REPRESENTING THE VIEWS OF THE BRITISH SOCIETY FOR RHEUMATOLOGY.

My report will follow the following format:

3. Professional and collegiate relationships with Prof Fouad Fayad

I have known Prof Fayad both as a colleague and friend for many years. I am fully aware of his clinical competence and academic achievements. I have visited him at his place of work Hôtel-Dieu de France, Beirut. I successfully sponsored him for the Fellowship of the Royal College of Physicians and Surgeons of Glasgow. I am fully satisfied with his high professional standards and integrity, and I am happy to provide this report without bias or prejudice.

4. Recap on the details relating to the matter of the published paper under consideration:

- I. I have reviewed the published paper by Ziade et al and the main concern related to the methodology section which did not include any mention of the missing data of the index Ankylosing Spondylitis patients and the blood donor group. Neither was there any mention of the recalculation of the cut off threshold of the IgG assay used despite significant email exchanges between Dr Ziade and the German co-authors Nicklas Baerlecken and Torsten Witte. It is evident that Dr Baerlecken was against manipulating the manufacturers calculated threshold of the IgG4 assay however Dr Baerlecken's view was overruled by Dr Witte despite the evident missing data due to lack of biological material and at one stage a mix up with the identification of samples sent from Lebanon.
- II. In addition, there was no mention in the manuscript in the light of the missing data, of recalculation of the threshold values for IgG4 and the methodology used in the final calculations out with the manufacturers assay threshold.

III. I note that Professor Pascale Salameh in her email of October 19, 2021, stated that "The results of the article seem consistent to me a priori; the calculations that have been made are correct. For the post-hoc analysis, similarly, the results seem consistent to me as well; the LR+cannot be calculated in several tables because the Sp=100% (the LR would be infinite), which is also correct."

However, it is not clear from her submission whether she took into account the number of missing data and which set of data she used. Was it the original native data entries for IgG4 levels using the manufacturer's cut off threshold or that used by the authors using ROC analysis?

- IV. In their report, the Inquiry Commission stated that "In support of this position, (Prof Fayad) puts forward the opinion of an internationally recognized expert, Pr. Nassim TALEB. The members, while recognizing the eminent scientific qualities of the expert, regret that the opinion was sought from an economist and not from an expert in biostatistics."
- V. This is a very surprising statement on two counts. First Prof Taleb's opinion was sought by Frontiers publications as evident in his email to Prof Fayad dated 1 September 2021 which included an invitation from Frontiers in Public Health Editorial Office to review a manuscript relating to paediatric services in China. So, the question about his suitability to opine in this case does not arise.
- VI. Second, the respectful members of the Inquiry Commission might have missed that in many respects, Statistics and Biostatistics according to Robert Weiss UCLA Biostatic Professor, are quite similar and many Biostatisticians would feel comfortable in a statistics Department and vice-versa. In Biostatistics, the research problems are generally motivated by real data sets and problems from Public Health, Biology and Medicine. So, on that count the preference to discount Prof Taleb's opinion is not justified and contributed in a very significant negative way to Prof Fayad's contention that the integrity of the data used was suspect.
- VII. It is also important to note that the Inquiry Commission concluded that "after having deliberated at length, the members unanimously agree that they are not in a position to confirm or invalidate the reproaches of "manipulation of scientific data".

5. Informed opinion and conclusion:

I have reviewed the available evidence based on the submitted myriad of documents with reference to the question whether the published manuscript by Ziade et al stand to scientific scrutiny as regards the integrity of the data used and the conclusions derived from such data. I did not include in my assessment the other issue of disharmonious professional amongst staff at HDF Rheumatology depart.

In my opinion and as a practicing clinician involved in reasonable amount of collaborative clinical research find that the methodology used, and the conclusions made in the published manuscript by Ziade et al raise significant cause for concern and requires more focused, independent, and unprejudiced analysis of the data generated by the investigators.

It is also my opinion that Prof Fayad acted properly in raising his concerns regarding the published manuscript and that any retaliatory actions by those in power against his professional integrity and standing is wholly unjustified and will be nothing less than a travesty of natural justice.
