Re: Dr. Stacy Blain/Research Misconduct Proceeding

Dear Ms. Bulls:

Thank for your January 25, 2022 letter regarding a research misconduct proceeding involving Dr. Stacy Blain. We greatly appreciate NIH taking the time to discuss the Dr. Blain Investigation Report (the "Report") with us and for NIH's advice and counsel on NIH funding issues as SUNY Downstate conducted the research misconduct proceeding.

As NIH knows, upon completion of the Investigation Committee's Report, and its acceptance by our Deciding Official, we provided the Report, and our pending institutional actions, to the Office of Research Integrity ("ORI"), which is currently undertaking its review process. Soon thereafter, we provided NIH with a written summary of the Report ("Research Misconduct Final Investigation Report: Extracted Sections for NIH Office of Extramural Research") which included, among other points, a statement that Dr. Blain had violated institutional policy by virtue of having declined multiple requests to review lab notebooks and identify data that she asserted supported certain figures in question in the research misconduct proceeding.

Your January 25th letter focuses on that policy violation and explains that NIH "may withdraw approval of the PD/PI . . . if there is a reasonable basis to conclude that the PD/PI [is] . . . no longer qualified or competent to perform the research objectives. In that case, the awarding IC may request that the recipient designate a new PD/PI . . ." per NIH Grants Policy Statement 8.5.1. On that basis, we understand that NIH expects SUNY Downstate to either designate an alternate Principal Investigator (PI) for the awards on which Dr. Blain currently serves as PI or request their bilateral termination.

Please be assured that we greatly value our partnership with NIH and fully understand NIH's position that its decision with respect to the awards on which Dr. Blain currently serves as PI is discretionary and thus not subject to appeal. We did, however, want to provide NIH with some additional information and context. While SUNY Downstate takes policy violations very seriously, we also consider carefully the appropriate sanction when we identify a violation. To that end, if Dr. Blain's policy violation had occurred in a vacuum, *i.e.*, without accompanying findings of research misconduct, it is unlikely that we would seek to remove her from serving as a PI. Rather, we would likely counsel her on responsible research practices and/or impose some degree of scientific oversight on her lab. We also wanted NIH to understand that the policy violation was not the sole basis for any of the research misconduct findings in the Report. The Committee assessed each allegation against the requirements set forth at 42 C.F.R. § 93.104.

We make these points because it appears that NIH's action is based solely on the policy violation and we wanted to ensure that NIH understands the relevance of that violation and its impact on the Report's findings. If we do not hear from further from NIH on the issue of a replacement PI or bilateral termination, we will proceed in accordance with NIH's directive.

As for the remaining questions in NIH's January 25th letter, we provide the following information:

- *Why funds in the amount of \$52,763.37 were withdrawn for grant R01 CA249667, as SUNY Downstate indicated that no funds would be withdrawn to protect the Federal funds during the research misconduct proceedings.*

The FCTR report in the PMS is used to report all expenditure activity, not just the expenses we have drawn down and received cash for. The FCTR form and PMS titles these expenses as disbursements and this can lead to some confusion. Please be assured we have only reported expense activity, as no stop work order has been initiated and the grant (document) is active and fully funded on the PMS. The Research Foundation for SUNY has not drawn any funds from document RCA249667A. We have placed internal controls on the award in our system to prevent any expenses incurred on the grant from generating an accounts receivable invoice. All draw activity at the Research Foundation is based on open AR invoices only. If an invoice does not generate we do not draw. No invoice will generate until we remove the controls from the grant in our system. The funds you see reported on the PMS as "disbursements" reflect expense activity only and no cash has been disbursed nor requested nor drawn down. The entire expense amounts reported on document RCA249667A represent a portion of the Research Foundations final cash position which is a deficit (expenses exceed cash drawn). As of QE 9/30/21 we reported expenses on document RCA249667A of \$52,763.37 and our overall cash position deficit was reported as -\$4,911,387.57. Expenses reported on document RCA249667A are part of that almost \$5M cash deficit. As of QE 12/31/21 we reported expenses of \$153,800.62 and overall ending cash position of -\$10,663,967.05. Again, expenses reported on document RCA249667A are part of this \$10.6M cash deficit.

The PMS does have reports available that can confirm we have not drawn down any funds on doc RCA249667A. Below is a screenshot of the Account Balance Inquiry available on the PMS. This inquiry shows the total funded amount of the document, the total funds drawn, and the available cash balance on the document. As you can see no funds have been requested nor received for the award in question and the fully funded amount is still available.
